- **August 2<sup>nd</sup> 2024**

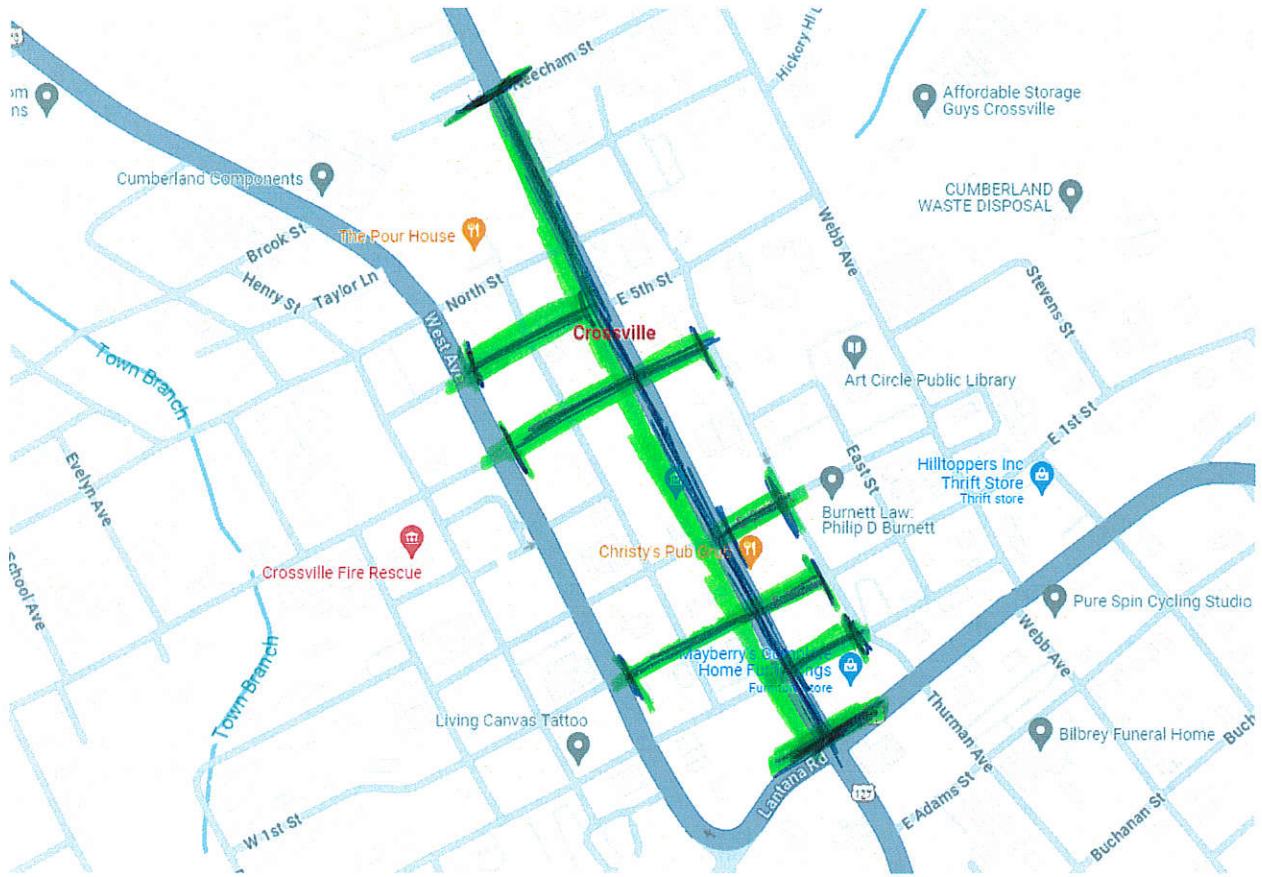
We would like to have the streets closed at **approximately 3:45pm**. Then reopening at **8:15pm**.
