You are hereby notified to appear before the Beer Board of the City of Crossville, Tennessee, on Tuesday, December 8, at 5:30 p.m. to answer a charge of violating the §8-212(F) of the Crossville Municipal Code, a copy of which is attached hereto and made a part hereof. This charge is based on citations provided by the Crossville Police Department of a violation of T.C.A. §57-5-301 by employee Rebecca Marie Jackson on October 21, 2020. Rebecca Marie Jackson is charged with selling beer to persons under the age of 21.





