**OTHER BUSINESS**

2. Discussion and possible action on retiree rehires
- City Manager Greg Wood reviewed the issues on the rehiring of retirees that are in the Tennessee Consolidated Retirement System. He recommended a 5% reduction on salary and payback of the retirement incentive and other retirement bonuses so that there would be no duplication when they retired again.*
- Councilmember Wyatt asked for information on the savings to the city from the buyout (retirement, payroll and insurance).*
- It was pointed out that the 18% now contributed to TCRS is based on the actuarial tables and could vary, dependent on circumstances.*
- Mayor Pro-Tem Graham asked that the COLA these employees would be entitled to in the next 5 years be used to reduce the repayment of the buyout.*
- No action was taken, pending receipt of the additional information.*
- This Policy was deferred**
