Traffic Signal Replacement

RE: Formal Request for Extension based on Supply Chain Issues for material.

This is a formal request for an extension of the project due to supply chain issues for material. Our cabinet had an original estimated ship date of October 9th, 2023, but on May 15th, 2023, we were advised that the lead time was then extended to December.

Timeline of events is as follows:

October 19th, 2022, the submittal package was sent to the city for approval.

November 18th, 2022, the submittal package came back from the city with notes on the Click 650 unit.

November 29th, 2022, I sent a reminder to the city that I needed an answer on the Click 650 unit to release the rest of signal equipment.

November 30th, 2022, the PO to TCS for the cabinet was released into production.

December 1st, 2022, we were given the estimated ship date of October 9th, 2023, from TCS.

December 5th, 2022, the estimated ship date of October 9th, 2023, was provided to the city.

December 7th, 2022, we submitted alternate signal equipment and cabinet with an improved lead time of 16-18 weeks vs. the 45-week lead time from McCain to the city.

December 9th, 2022, a response was received back from engineers/city advising "IF the city decides to move forward with the alternate Peek/Oriux equipment versus the originally requested McCain equipment, please verify the anticipated construction completion date. Per the attached schedule (**223149 Schedule Update 12.6.22.pdf**), we understand that if the originally proposed equipment is provided, the Project Completion Date is 12/25/23."

The response from the city regarding this email string and proposal was a signed work change directive 1 for the changing of illuminated signs to non-illuminated signs but nothing was mentioned about the alternatives, so we proceeded with the McCain equipment. With proceeding with the McCain equipment, I checked with the manufacturer yesterday morning who stated that cabinet is "looking at



December 2023, plan on end of month". With this being the case, our new proposed completed date is now February 19th, 2024.





Per the attached Supplemental Agreement and/or Request for Construction Change – Change Order Request #01, please note the following:

- As you may recall, shortly after the project was awarded, the City requested the contractor to
 provide standard reflective overhead street name signs in lieu of the proposed internally lit name
 signs for a savings of \$12,798.00.
- Stansell Electric Company (SEC) recently requested a time extension based upon supply chain issues, for which a letter from them and their supplier has been provided. You may also recall that during the Pre-Construction meeting, concerns where discussed on supply chain issues and it was agreed upon that time extensions would be preferred to secure the specific traffic signal equipment in lieu of accepting alternate equipment.

Recognizing the City's intensions to maintain similar street name signs to other existing signs and understanding that the supply chain issues where encountered in an effort to the same traffic signal equipment utilized at other existing traffic signal controllers, we are in agreement with the requested savings and time extension.
