AN ORDINANCE TO ADJUST THE CORPORATE BOUNDARIES OF CROSSVILLE, TENNESSEE.

WHEREAS, it now appears that the prosperity of this city and of the territory herein described will be materially retarded and the safety and welfare of the future inhabitants and prosperity thereof endangered if such territory is not annexed; and

WHEREAS, the annexation of such territory is deemed necessary for the welfare of the future residents and property owners thereof and of this city as a whole;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROSSVILLE, TENNESSEE that:

SECTION I. The following described areas, lying the first Civil District of Cumberland County, Tennessee are hereby annexed into the corporate limits of Crossville, Tennessee:

## Satsuma Drive (Canary Drive to Camelia Drive)

BEGINNING on a point, said point being a common property corner of Tax Map 112L A 32.00 and Tax Map 112L A 31.00 located on the southeastern ROW of Satsuma Drive; thence in a southwestern direction following the existing City Limits across the ROW of Satsuma Drive, Tax Map 112L A 4.00, and Tax Map 112L A 5.00 to a point, said point being on the common property line of Tax Map 112L A 5.00 and Tax Map 112L A 6.00; thence in a southeastern direction following the common property line of Tax Map 112L A 5.00 and Tax Map 112L A 6.00 to a point, said point being a common property corner of Tax Map 112L A 5.00 and Tax Map 112L A 6.00 located on the northwestern ROW of Satsuma Drive; thence in a southwestern direction following the north western ROW of Satsuma Drive to a point, said point being a common property corner of Tax Map 112L A 6.00 and Tax Map 112L A 7.00; thence in a northwestern direction following the common property line of Tax Map 112L A 6.00 and Tax Map 112L A 7.00 to a point, said point being the point of intersection of the existing City Limits and the common property line of Tax Map 112L A 6.00 and Tax Map 112L A 7.00; thence in a southwestern direction following the existing City Limits crossing Tax Map 112L A 7.00 and Tax Map 112L A 8.00 to a point, said point being a common property corner of Tax Map 112L N 13.00 and Tax Map 112L N 13.00; thence in a southwestern direction following the existing City Limits to a point, said point being a common property corner of Tax Map 112L N 19.00 and Tax map 112L A 16.00 located on the northeastern ROW of Camelia Drive; thence in a southeastern direction following the northeastern ROW of Camelia Drive to a point, said point being a common property corner of Tax Map 112L A 17.00 and Tax Map 112L G 41.00; thence in a northeastern direction following the common property line of Tax Map 112L A 17.00 and Tax Map 112L G 41.00 to a point, said point being a common property corner of Tax Map 112L A 17.00 and Tax Map 112L G 41.00 located on the southwestern property line of Tax Map 112L A 18.00; thence in a southeastern direction following the common property line of Tax Map 112L A 18.00 and Tax Map 112L G 41.00 to a point, said point being a common property corner of Tax Map 112L A 18.00 and Tax Map 112L G 38.00; thence in a northeastern direction following the southeastern property lines of Tax Map 112L A 18.00, 112L A 19.00, 112L A 20.00, 112L A 21.00, 112L A 22.00, 112L A 23.00, 112L A 24.00, 112L A 25.00, 112L A 26.00, 112L A 27.00, 112L A 28.00, 112L A 29.00, 112L A 30.00, and 112L A 31.00 to a point, said point being a common property corner of Tax Map 112L A 31.00, Tax Map 112L A 32.00, and Tax Map 112L B 2.00; thence in a northwestern direction following the common property line of Tax Map 112L A 31.00 and Tax Map 112L A 32.00 to a point, said point being the BEGINNING, approximately 10.9 acres.

SECTION II. Pursuant to <i>Tennessee Code Annotated</i> §6-51-102(b)(4), a Public Hearing on this annexation was held on <u>3/8/2011</u> , with legal notice of said Public Hearing advertised in the <i>Crossville Chronicle</i> on <u>2/18/2011</u> as well as all local radio stations.  SECTION III. This annexation shall take effect from and after its final passage and pursuant to <i>Tennessee Code Annotated</i> §6-51-102, the public welfare requiring it.
