ITEM #14 - MATTERS RELATIVE TO GRANITI FIANDRE PROJECT

As part of the mitigation required for the ARAP permit to relocate the creek for the GranitiFiandre project, 16+ acres of wetlands were required to be restored to a wetland habitat. A Permanent Conservation easement has been negotiated on the Baisley property located near the intersection of Frost Road and Dykes Road. The cost is \$45,000. These costs will be included in the costs of the TIIP grant and reimbursed at 77%.
