Subject: North West Bypass Position Paper

This position paper is my opinion and does not constitute the position of the city of Crossville or other elected officials.

When stated as did herein documentation or corroboration is available to support credibility to anything in this paper. Statements that say reasonable is assumed on the basis that any reasonable person would come to the same conclusion.

BACKGROUND: Prior to running for office I witnessed the runaway purchases of property by the city at inflated values that no reasonable person would have done, that being the airport property and industrial park that has not bore fruit. Then one evening I listened to the cities representative try to convince John Turner to sell his land. With the aid of elected officials they were to secure land or use land presently in their possession and thus capitalize on the development at tax payer expense. It was donated to the tune of a half a million dollars. It is noted Mr Marlow did not vote on this. It is also noted who received the most lucrative settlement.

Now we have the NW connector almost completed. Citizens are calling it the road to no where (not accurate), and the Graham, Mitchell, Marlow expressway. So much for the confidence of the people.

I have no problem with people speculating or developers making money. I have serious issues with officials who use their office to increase their personal wealth and that of their friends and relatives. It does not take a genius to follow the party, pattern, or motive on the recent request for annexation of Land owners to the city.

Well Mayor Graham has a long history of business with Tom Looney it is noted that he sold some of this property to the mayor that was sold back to the City. It is also noted that the Mayor did accounts for enterprises of Dean Bennett/Tom Looney when at the sponsorship the city contracted office space without a disclosure that he did business with him. The same gos for Crossville Aero as the mayor has voted on that Company well concurrently doing its accounts and maintaining a business relationship. The error is not by the parties mention but the failure to disclose the business relation of a vendor and then voting on issues. It is no wonder I get phone calls from people in Cookville over the Mayors role in the UCDD scandal.

My position is this I will not accept the conduct of any official that uses his or her office to increase their personal wealth, that of their family, or that of their friends without publicly challenging their ethics or motives, no exception.

If the developers along the NW Connector want utilities so they can profit then they not the tax payers need to come up with a financial plan. There Is no way in hell your going to slip this by it will have as much success as Tansi.
