Matters relative to certified tax rate

The certified tax rate has been received from the Assessor of Property. The new rate is \$0.53. Council discussed holding a public hearing at the July meeting setting the tax rate above the certified tax rate.

City Manager Wyatt presented the new tax rate. It was pointed out that residential rates went down and commercial and undeveloped land went up. The difference in revenues is about \$70,000.

The City Clerk discussed the requirements to adopt a tax rate different than the certified tax rate. Mayor Graham pointed out the deficit in the collection of sales tax and the loss of growth in residential houses. He also pointed out the loss in revenues from interest rates. He believes the long-term solution affects both revenues and expenses.

The current general fund budget is in a deficit of about \$1,000,000. To maintain a six month reserve, we need to have about \$6,000,000-\$7,000,000 in fund balance.

Councilman Marlow stated he would rather see small increases in the taxes rather than one large one or a charge for garbage pick-up.

A motion was made by Boyd Wyatt, seconded by J.H. Graham III, that the certified tax rate be accepted . The motion carried by the following vote:
