### 1. Appointments

 a. Discussion and action regarding Municipal Court Judge and Administrative Hearing Officer

City Council has received the resignation of Judge Ivy Garnder-Mayberry effective September 30, 2023. The City Council discussed the selection process and whether there is a need to appoint an interim Municipal Court Judge. Court is scheduled for October 17, 2023.

Letters of interest and qualifications for Municipal Court Judge and Administrative Hearing Officer were received on September 29, 2023. The following attorneys applied: Kevin Poore, Brett York, Jeffrey Vires, Hayden Shadden, Tiffany Lyon, and Nathan Clouse.

The City Council agreed to select a candidate immediately and discussed how they would narrow down the candidates.

A motion was made by Mayor R.J. Crawford, seconded by Council Member Scot Shanks, to vote by paper ballots with each City Council member choosing two candidates to narrow the field, and then conduct additional rounds of voting until a majority of votes for one candidate is received. The motion carried by the following vote:
