Good Afternoon Greg,

I just got off the phone with John Stubbs, and he indicated that the price for concrete has increased, the price for steel has increased, and other miscellaneous costs have increased. He said that the increase in the items above translate to a 3% increase to the project budget, or a \$27,493 increase in the overall cost to perform the terminal renovations at the Crossville Memorial Airport – Whitson Field. Therefore, the overall total cost for the anticipated project would be \$943,943.50.

I would have to get with Michael to formulate the grant breakdown, but based on the amounts and percentages estimated previously:
