During their inspection fire personnel observed suspicious items and odors that made them believe dangerous narcotics were being kept in the apartment. Officer Coleman conducted his investigation and, along with Crossville Police Detectives, a search warrant was obtained to seize the items in the home. Items seized were Digital Scales with marijuana on the scales, a gallon sized baggie containing marijuana, a rifle and cash. The total weight of marijuana seized that evening was approximately 2 ounces.

This case is set to be reviewed by the Grand Jury for indictments.
