

**REGULAR MEETING: MARCH 9, 1999**

Lake dam as discussed. Roll call votes: Ayes-(5)Graham, Hill, Kerley, Turner, Wyatt; Noes-(0). Motion carried.

**ITEM #9 – MATTERS RELATIVE TO RETIREMENT INSURANCE**

Councilman Kerley proposed that the City continue employees' health insurance benefits for those who retire at age 55 with 30 years of service to the City of Crossville or at age 60 with 20 years experience with the City until they are eligible for Medicare benefits. Any costs for family coverage to the retiree would be deducted from their retirement check.

A motion was made by Councilman Kerley, seconded by Councilman Wyatt, that the City pay employees' health insurance benefits until they are eligible for Medicare benefits if they retire at age 55 with 30 years of service with the City of Crossville or at age 60 with 20 years service with the City of Crossville. Roll call votes: Ayes-(5)Graham, Hill, Kerley, Turner, Wyatt; Noes-(0). Motion carried.

**ITEM #10 – MATTERS RELATIVE TO SOUTHERN STANDARD PLUMBING CODE**

A motion was made by Councilman Kerley, seconded by Councilman Hill, that the ordinance adopting the Southern Standard Plumbing Code be passed on first reading. Roll call votes: Ayes-(5)Graham, Hill, Kerley, Turner, Wyatt; Noes-(0). Motion carried.

A fee schedule will need to be reviewed and adopted prior to final adoption of the ordinance. City Manager Walker will be transferring Jeff Kerley to Codes Enforcement to provide inspections since he is already certified as a plumbing inspector. He will also assist the Building Inspector in other inspections, issuing permits, and continuing with back-flow prevention and inspection.

**ITEM #11 – MATTERS RELATIVE TO LITTER PROGRAM**

Councilman Hill asked for input from the citizens and Council on inputting a litter pick-up program.

**ITEM #12 – CITY ATTORNEY'S REPORT**

Donnie Isham's sewer – Mr. Colvard reported that he visited the Isham home with Mr. Isham and could not find that the City did anything wrong in the installation of the sewer lines. It did appear that the contractor was outside the construction easement, but that would be between the contractor and Mr. Isham. A work session will be held later on concerning all complaints from the three sewer projects.

**ITEM #13 – CITY MANAGER'S REPORT**
