

RESOLUTION

A RESOLUTION TO ADJUST THE CORPORATE BOUNDARIES OF CROSSVILLE, TENNESSEE.

WHEREAS, it now appears that the prosperity of this city and of the territory herein described will be materially retarded and the safety and welfare of the future inhabitants and prosperity thereof endangered if such territory is not annexed; and

WHEREAS, the annexation of such territory is deemed necessary for the welfare of the future residents and property owners thereof and of this city as a whole;

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CROSSVILLE, TENNESSEE that:

SECTION I. The following described areas, lying the first Civil District of Cumberland County, Tennessee are hereby annexed into the corporate limits of Crossville, Tennessee:

**Legal Description for Annexation of Tax Map 139, Parcel 9.03
(4341 Hwy. 127S)**

BEGINNING on a point, said point being a common property corner of Tax Map 139 parcel 9.02 and Tax Map 139 parcel 6 on the northwestern ROW of HWY 127 South; thence in a southeastern direction crossing the ROW of HWY 127 South to a point, said point being a common property corner of Tax Map 139 parcel 10.00 and Tax Map 139 parcel 9.03; Thence in a south eastern direction along the common property line of Tax Map 139 parcel 10.00 and Tax Map 139 parcel 9.03 to a point, said point being a common property corner of Tax Map 139 parcel 9.03 and Tax Map 139 parcel 9.01; thence in a southwestern direction following a common property line of Tax Map 139 parcel 10.00 and Tax Map 139 parcel 9.03 to a point, said point being a common property corner of Tax Map 139 parcel 10.00 and Tax Map 139 parcel 9.03; thence in a northwestern direction following a common property line of Tax Map 139 parcel 10.00 and Tax Map 139 parcel 9.03 to a point, said point being a common property line of Tax Map 139 parcel 9.00 and Tax Map 139 parcel 9.03; thence in a northeastern direction following a common property line of Tax Map 139 parcel 9.00 and Tax Map 139 parcel 9.03 to a point, said point being a common property corner of Tax Map 139 parcel 9.00 and Tax Map 139 parcel 9.03; thence in a northwestern direction following a common property line of Tax Map 139 parcel 9.00 and Tax Map 139 parcel 9.03 to a point, said point being a common property corner of Tax Map 139 parcel 9.00 and Tax Map 139 parcel 9.03 and located on the southeastern ROW of HWY 127 South; thence in a northwestern direction crossing the ROW of HWY 127 South to a point, said point being approximately 57 feet southwest of the common property corner of Tax Map 139 parcel 6 and Tax Map 139 parcel 9.02; thence in a northeastern direction following the northwestern ROW of HWY 127 South to a point, said point being the BEGINNING, containing approximately 1.18 acres.

SECTION II. Pursuant to *Tennessee Code Annotated* §6-51-102(b)(4), a Public Hearing on this annexation was held on July 9, 2015, with legal notice of said Public Hearing advertised in the *Crossville Chronicle* on June 17, 2015 as well as all local radio stations.

SECTION III. This annexation shall take effect from and after its final passage and pursuant to *Tennessee Code Annotated* §6-51-101, et seq, the public welfare requiring it.
