

You are hereby notified to appear before the Beer Board of the City of Crossville, Tennessee, on Tuesday, December 8, 2020 at 5:30 p.m. to answer a charge of violating the §8-212(F) of the Crossville Municipal Code, a copy of which is attached hereto and made a part hereof. This charge is based on citations provided by the Crossville Police Department of a violation of T.C.A. §57-5-301 by employee Kimberly Grace Cranmore on October 21, 2020. Kimberly Grace Cranmore is charged with selling beer to persons under the age of 21.

The City of Crossville will consider at this time whether or not to revoke, suspend, or assess a fine against your beer permit at Price Less IGA #495. You will be afforded the opportunity to call witnesses on your behalf and are welcome to be represented by an attorney. Witnesses will be called to testify as to this violation.


