## Scoreboard Status Report:

Until 2015, all P&R scoreboards have been the property and responsibility of the Coca-Cola Company. As of 2015 they are no longer in the scoreboard business in any way.

## Warner Complex Scoreboards:

Fields 1 and 3 are original boards that are at least 20 years old (were here when Mrs. French began employment). We are unsure if they were installed new or used. Approximately 10 years ago, fields 2 and 4 boards became a constant maintenance issue. The Coke repair people were out on multiple occasions and turned them in for replacement. They did deliver 2 boards for the City to install, both boards in used condition but better than what was in place.

## Turner Complex Scoreboards:

These 6 boards were installed new during the construction of the facility in 2001.

Each board has 2 central pieces that consistently are the root of most maintenance issues. All boards have at least one, sometimes two "packs". This is the brain of the board. These packs can no longer be bought new, but must be sent in to the factory to be refurbished at a cost of \$250.00 each. Your own pack is not returned rather whatever board they have. The second piece is the "controller" that the scorekeeper uses to control the board. It is a hard wired box that must be plugged in to work. These boxes and wires take a lot of abuse from handling and careless users. They can still be purchased new to replace if needed. Replacement cost is \$250.00 per controller.

In addition to the pack and controller problems, boards are often compromised by birds and lightening. Birds make their way into the housing unit and nest in and around the workings of the board. Almost every repair visit, bird nests are removed. Lightening is a problem as well. We think the underground cables are the root of a lot of the lightening issues. Due to the age of these units, they don't have the lightening protection built in that newer models do.

Obviously, the boards are showing their age in appearance as well. Our maintenance staff has hand painted a couple of the boards here and there, but they have never been refinished and completely freshened.

As of Tuesday, 11/28 all 10 boards were working. Turner 3 field would not come on, Rick exchanged the pack with a back-up we keep on hand, it came on but very dimly. He then exchanged it with our 2<sup>nd</sup> backup pack (we keep 3 on hand) and the board did come on as it should. Both of these backup packs were replaced, refurbished pieces. Experience shows though, that just because they worked at that time does not mean they would work just a few hours or days later.

In short, the boards are being maintained to the best of our ability, but are just unreliable and need to be replaced.

If replacement is budgeted, in order to accommodate the existing poles, we will need at least a 12' wide board. Staff would like to go wireless and eliminate the underground cables and hopefully lessen lightning strikes. They also recommend the purchase of a portable board for the flag football league's use.

Note: Currently, the boards are used by the church league, women's league and JFK youth league. The men's league and CYBS youth league do not use them. Most tournaments do not use them as it is an additional expense to pay a scorekeeper. Many, many years ago, the department did pay for scorekeepers for the local youth league (only). We hired, scheduled and paid them out of P&R budget.

The Coke contract was signed and effective 7/1/2015 for a period of two years, with 3 one year extensions available. The contract stated Coke would pay the city \$12,000 in year one for upfront scoreboard funding. This payment processed 12/23/2015 on DCR 1507, deposited in account 110-37990. Year two was another payment of \$5,000. It has not been paid. Staff has spoken with the Coke Rep and she said she will get it processed ASAP.
