The People That Fair Park Serves

Some seniors are unable to drive any longer or are financially unable to own a vehicle. Other seniors are in poor health and unable to cook. Many have no family in the area and no means of getting around since Crossville has no public transportation. If these people can connect with the Center, they can be provided with nutritious meals, access to health screenings, physical fitness, health education, legal aide, general education speakers and a very important factor in all lives — companionship. Providing transportation to seniors for these activities help keep our seniors active and healthy, giving them an incentive to get out and join in their community functions.

Achievements and Activities

The Fair Park Senior Center's annual fundraiser Pioneer Day on the Mountain/
Heritage Festival is scheduled for September 2013. For 2014, the date will be the 3rd
Saturday in September. Additional fundraisers were held at the Palace Theater on 2/17
(The Gong Show), 6/29/12 (Crossville's Got Talent), and 12/15/12 (Christmas Show).
Several fundraisers are anticipated to be scheduled at the Palace in 2014 as well. Fair
Park also spearheaded a "Senior Police Academy", held in Crossville, Lake Tansi, and
Fairfield Glade. These programs were held over an eight-week period at each location
with thirty participants in each class. The Upper Cumberland Senior Olympics was held
in May, with nearly 300 participants, in Crossville, Fairfield Glade, and surrounding
counties.

How United Fund's Allocation Has Been Spent

Second Harvest Food Bank

During 2012:

- o Over 11,000 senior participants obtained meals, snacks, and food giveaways over the last year.
- Nearly 12,000 pounds of food have brought in via the Center van from the Second Harvest facility in Knoxville for senior participants, twice the amount brought in last year.

STATEMENT OF NEED

Since the senior population in Cumberland County is rapidly growing, with the percentage of population approximately 34% over age 60 (according to 2010 Census data), Fair Park has identified a crucial need in this community. With the problems inherent with age, such as decreasing vision, poor reflexes, and isolation, seniors are more prone than any other population to live alone and thereby lose access to vitally needed services as well as socialization with their peers.

We have found that our van program is vital to the senior community. Our goal is to continue to keep older residents active and make a difference in their daily routine, since many are simply unable to provide transportation for themselves due to health or age or financial status. Our van can provide a feeling of security for these people since they can depend on being able to get out and continue to be active.

During the year 2013, our van program has served approximately 5,600 seniors in some capacity. We expect more for 2014 due to the continuing increase in Cumberland County's senior population.

Our van program is based primarily at the Center, with currently one part-time staff member who drives the van. Occasionally, volunteers will help out with driving trips; however, the staff person is responsible for scheduling the van trips and also fueling, maintaining, and cleaning the van.

The van itself is a 13-passenger Dodge conversion van purchased in 1999 with the help of a state grant and a 20% match from the City of Crossville. Since the inception of the program, the van has transported area seniors to and from the Center to take advantage of the many programs, hot meals, and social interaction provided. Short day trips are scheduled throughout the year, both educational as well as recreational trips. Seniors in organized walking programs are transported to area trails, and the van is used twice each



One of its most valuable programs is its van, sponsored by the United Fund.

The van is used in a variefy of ways like transporting the visually impaired, making it possible for the center's New Horizon Adult Day Care to take clients and volunteers to numerous caregiver workshops. The yan is also utilized by instructors to attend fitness training classes for programs such as Silver Sneakers, and Tai Chi teachers are taken for training to be licensed by the National Arthritis Foundation.

Having the van gives

seniors the opportunity to attend : the Federation for the Aging Conferences and Senior Day on the Hill at the State Capitol. It is also used to bring Second Harvest Foods to seniors at the center. The van gives many of the seniors the opportunity to access hot nutritious meals, recreation and health programs that are available at the senior center. The van program opens up the door for seniors to attend health fairs, and most of all fun trips with friends.

Many of these programs would not be possible without the United Fund sponsorship for the Fair Park Senior Center van. The United Fund provides the funding to operate one van, which in turn helps to make a change in so many lives in so many ways for seniors in Cumberland County.
