- *no new Police officers*
- *no new Fire officers*
- *split the expenses for the Public Works radios with Water/Sewer and schedule a work session on radios the final decision being deferred*
- *Fire - delete defibulators and generators*
- *110-42420-269 Codes Administration possibly reduce to \$50,000*
- *Steve to check on trailer for Parks & Recreation*
- *delete Parks & Recreation pole barn and see if it can be constructed by force account*
- *work session to be scheduled on recreation master plan*
- *Steve and Sally asked to get playground concepts for Meadow Park*
- *Meadow Park Lake trails - reduce to \$10,000*
