#### **Ordinances on Second Reading**

a. Ordinance approving the abandonment Right-of-Way for a portion of Livingston Road

The City of Crosville and the Sports Authority of the City of Crossville are proposing the abandonment of ROW and dedication of new Right-of-way for Livingston Road. The Crossville Regional Planning Commission has recommended approval to abandon a portion of the Right-of-Way on Livingston Road.

#### **Ordinances on First Reading**

b. Ordinance amending Title 5 Chapter 7 - Hotel/Motel Occupancy Tax

Upon passage of the changes to the Charter, the hotel/motel occupancy tax ordinance must be updated to accurately reflect the changes to the Charter. Staff also recommends updating the definition of "hotel."

This Ordinance was approved on first reading

**c.** Ordinance amending §3-202 - Imposition of Fines, Penalties, and Costs

The 114th General Assembly of the State of Tennessee passed Public Chapter 459 amending Tennessee Code Annotated, § 16-18-304(a) to increase the municipal training education fee from \$1.00 to \$2.00 that takes effect on July 1, 2025. The City of Crossville wishes to amend its court cost to reflect this legislative change. The City of Crossville has determined that it is in the best interest of the City to amend Title 3, Chapter 2, Section 3-202 regarding court costs and set a revised court cost amount.

#### **Additional Consent Items**

d. Approval of annexation and Plan of Services for Rhododendron Cir Martin Property

The Crossville Regional Planning Commission has recommended a standard Plan of Services and annexation for the properties requesting annexation along Rhododendron Circle (TMP 112D J 013.00, 113H F 012.00 & 011.00).

This Resolution was approved as recommended.

e. Approval of annexation and Plan of Services for Rhododendron Cir - Cooper Property

The Crossville Regional Planning Commission has recommended a standard Plan of Services and annexation for the property requesting annexation along Rhododendron Circle (TMP 112D J 037.00).

This Resolution was approved as recommended.

Approval of annexation and Plan of Services for Halstead Drive

The Crossville Regional Planning Commission has recommended a standard Plan of Services and annexation for the property requesting annexation along Halstead Drive (TMP 126A C 019.00).

They intend to install a sewer line due to a failing septic system. A financial guarantee will be required for the installation of the sewer line.

Approval of CCHS Homecoming Parade Route

Cumberland County High School has requested a temporary street closure for their homecoming parade on Thursday, October 9, 2025 at 1:30 p.m. The closure would begin just before 1:30 p.m. and end as soon as the parade concludes. CCHS has requested the following route: Start at the school on Stanley Street, turn left on to Main Street, turn left on to 4th Street, and end at the school.

This Permit was approved as recommended.

j. Approval of Granicus Services Agreement

Approval is requested for renewal of the Granicus Services Agreement, which is the software used for Council meetings. This renewal is for one year and the cost is \$1,863.34 per month, which is an increase of \$169.39.

#### **Bids/Purchases**

I. Approval of Miller Avenue Water Booster Station

Bids were received for the Miller Avenue Booster Station on June 26, 2025. Staff recommends low bidder W&O Construction be awarded the bid. The bid is in the amount of \$2,160,000.00.

This Bids/Purchases was approved as recommended.

Approval of bid for Miller Avenue Water Line Extension to Connect to CWPA

Bids were received for the Miller Avenue Water Line Extension to Connect to CWPA on June 26, 2025. Staff does not recommend awarding the bid to the lowest bidder due to previous experiences with the contractor. Staff recommends awarding the bid to the second lowest and responsible bidder, Ironwood Construction, whose bid was in the amount of \$3,988,600.00.

This Bids/Purchases was approved as recommended.

#### n. Approval of Peavine Road Force Main bid

On June 17, 2025, bids were opened for the Peavine Road Force Main project. Staff recommends low bidder Hamilton Consulting and Construction be awarded the bid. The bid was in the amount of \$735,859.36.

Approval to award bid for Data Center Generator

IT Department Head Lee Lawson reviewed the bids for Data Center Generator and recommends awarding the bid to the lowest bid, Stubbs Construction Company for \$38,874.00.

#### 6. Other Business

a.

Discussion and action regarding a request for Outside City Sewer

The property owners of Tax Map 126 Parcel 021.00, which is located at 82 Fox Fire Road, at the intersection of Fox Fire Road and Lantana Road, are requesting outside City sewer connection. In their email to the City, they state that they were told they could tie into the City's sewer system for a small fee and the purchase of a grinder pump. They state that they purchased the property prior to the new annexation-related policies and are wishing to be grandfathered in and allowed to tie to the sewer without annexation.

Upon review of the deeds and the City ordinances, they purchased the property after the current Water and Sewer Connections and Main Line Extension ordinance (18-107) went into effect. According to their email and the deed records, they purchased the property on October 24, 2024. The ordinance passed third reading on September 10, 2024.

Per the current ordinance, outside City sewer can be granted if that existing sewer line is located outside the City limits and annexation is not feasible. Based on our GIS mapping, the sewer line that is located on Tax Map 126 Parcel 021.00 is located outside the existing City limits, but since the existing City limits is adjacent to Tax Map 126 Parcel 021.00, annexation is feasible. Under that determination, outside City sewer connection cannot be granted by Staff review. The property owner would have to request a variance to the Crossville City Council in order to be granted outside city sewer connection.

This item was presented to the Crossville Regional Planning Commission to make a recommendation to Council, but failed because of a tie vote. There is no recommendation from Planning Commission at this time.

City Council members discussed their thoughts on allowing connection. Mayor Pro-tem Gernt and Mayor Crawford expressed concern for setting a precedent by allowing for a variance. Council members Mayberry and Fox agreed Mrs. Hernandez had tried to do her due diligence, but due to the timing of the purchase and passage of the ordinance, she should be allowed the variance.

A motion was made by Council Member Mark A. Fox, seconded by Council Member James Mayberry, to grant a variance for outside City sewer connection. The motion carried by the following vote:
