Following a review of the planned construction and expansion of the spillway, the City and its engineers have determined that acquisition around the lake will not be necessary in order to keep the lake at the levels traditionally experienced, Councilman Wyatt moved that City staff be authorized to proceed with the bidding of the project and cease with the acquisition of flowage easements. 
Wyatt was a licensed prac-

City backs away from raising Holiday Hills Lake

Crossville City Council approved a motion by Pro-Tem Boyd Wyatt to cease acquiring flowage easements around Holiday Hill Lake necessary to raise the water level and instead, the city will. maintain the lake level at current, traditional

The city will move forward with bidding the project to repair the 40-yearold dam, widen the weir and rebuild the bridge across the dam. City officials hope to have the project under way in just a few months. The project has been on the city's plans for. several years and a number of preparations for the project, including the construction of a new road tying Holiday Hills and other nearby residential areas into the city since the bridge across the dam will closed for several months cutting off access to Sparta Highway while the bridge work is done, have

been implemented.

Wyatt said that after a review of the project and the needs of the city, it was determined that there was no need to acquire what were turning into expensive easements the city had been working toward for some time. The dam's improvements will allow the city to better maintain a consistent water level of the lake at the traditional

As the city moved further into the project of acquiring the easements, it became clear how costly purchases become including the costs of rebuilding some of the property owners' improvements such as seawalls, docks and boathouses.

The council approved actions required to move forward with the planned widening of Cook Road from Genesis Road, in front of Stone Memorial High School to Roane State's Crossville campus. The third reading of an ordi-
