Discussion and action on selection of City Manager

Council held a discussion about the final applicants and the feeling of the members of Council in the next steps to take in the selection process.

A motion was made by Mayor James Mayberry, seconded by Council Member Pamala Harris, to hire Greg Wood as City Manager, subject to him accepting an adequate salary that will be set tonight, the starting date, the contract to be negotiated, and an adequate background check. The motion carried by the following vote:

A motion was made by Council Member Danny Wyatt, seconded by Council Member Pamala Harris, that a two year agreement be offered at \$80,000 with a 10% increase in 6 months, upon Council approval; a six month's severance package, if terminated without cause before the end of the two-year period; and a \$2,500 moving allowance. The motion carried by the following vote:
