**Other Business****1. Discussion and action regarding the Azure hangar contract**

*A contract has been drawn up for Azure Flight Support to lease a hangar at the Crossville Memorial Airport to provide maintenance to airplanes. The hangar is currently being leased to Johnny Presley who will continue to lease from Azure Flight Support once the contract goes in to affect until his current contract ends for a reduced rate. Azure Flight Support has agreed to \$2,500 per month for 5 years with the option to renew at the end of the 5 year period.*

*City Attorney Randy York informed the Charter requires any lease longer than 2 years to be advertised for 30 days before the contract can be finalized. The contracts must first be approved by Council before the advertisement process can begin.*

- *Duration 30 + 10 years*
- *Insurance*
- *Rent \$2,000/month*
- *Utilities*
- *Sub lease / Partnerships*
- *Termination notice of 90 days*
