## **Ordinances on Third Reading**

a. Ordinance amending FY 24-25 budget

Several amendments are needed to the FY 24-25 budget.

The budget amendment for the vehicles are to buy out the leases on them. One is for a 2022 Chevy Silverado 2500 HD in the amount of \$16,254.79, and the other is a 2022

Chevy Silverado 2500 HD for \$19,144.04.

## **Ordinances on Second Reading**

**b.** Ordinance amending the site plan ordinance

Staff has requested to amend the site plan ordinance. Changes include adding hydrologic features to site plans and changing the time frame which staff has to review all site plans.

**c.** Ordinance amending FY 24-25 - Capital Projects

A budget amendment is necessary for FY24-25's capital projects.

#### **Additional Consent Items**

**d.** Approval of resolution for engineering services

Qualifications were received for engineering services regarding the 2024 Recreational Trails Program grant. Staff recommends selecting Wold-HFR for the engineer for this project to construct a trailhead at Meadow Park Lake.

This Resolution was approved as recommended.

**e.** Approval of Local Parks and Recreation Fund (LPRF) letter of intent and grant application

The City Manager is requesting to submit a letter of intent and to apply for a Local Parks and Recreation (LPRF) grant. The City's Master Parks and Recreation Plan will need to be updated to reflect the addition of the proposed playground equipment. This grant is a 50/50 match.

This Resolution was approved as recommended.

f. Discussion and action regarding Downtown Traffic Signal Replacement

A contract for full engineering and construction administration has been recommended for the traffic signal replacement at Fourth Street and South Main Street and First Street and South Main Street.

The cost for the engineering is \$97,500. Based on current estimates, the construction cost will not exceed \$1,050,000 based off of the recent construction cost of the Lantana and Main Signal Replacement project.

The proposal is for City funding only and indicates that construction plans could be

produced in about 3.5 months, but TDOT's review and approval could extend this time frame

This Contract was approved as recommended.

g. Approval of contract amendment regarding Hwy 127 North Phase 2 utility relocation Near Potato Farm Road to near Hollow Lane (PIN 100260.03)

The City currently has a contract with Hussey Gay Bell for the design and construction administration for the Hwy 127 N utility relocations. The amendment will provide surveying services including easement descriptions, parcel maps, and calculation of easement value based upon current City procedure.

This Contract was approved as recommended.

Approval of contract amendment regarding Hwy 127 N Phase 3 Utility Relocation Near Hollow Lane to Near Lowe Road (PIN 100260.04)

The City currently has a contract with Hussey Gay Bell for the design and construction administration for the Hwy 127 N utility relocations. The amendment will provide surveying services including easement descriptions, parcel maps; and calculation of easement value based upon current City procedure.

This Contract was approved as recommended.

Approval of TDOT Utility Engineering and Relocation Estimate for Hwy 127 N Phase 2 Utility Relocation Near Potato Farm Road to near Hollow Lane (PIN 100260.03)

The TDOT Utility Engineering and Relocation Estimate is attached. This estimate must be signed by the City Manager and submitted to TDOT so that the City can be reimbursed for a portion of the engineering services and the utilities can be relocated in the TDOT project.

This Contract was approved as recommended.

Approval of TDOT Utility Engineering and Relocation Estimate for Hwy 127 N Phase 3 Utility Relocation Near Hollow Lane to Near Lowe Road (PIN 100260.04)

The TDOT Utility Engineering and Relocation Estimate is attached. This estimate must be signed by the City Manager and submitted to TDOT so that the City can be reimbursed for a portion of the engineering services and the utilities can be relocated in the TDOT project.

Approval of contract amendment regarding Inspection for ARPA Sewer Projects

The Resident Observation budget for the ARPA sewer projects was set up with the intention of construction of the projects overlapping. The in-progress Bar Screens project doesn't have a budget for the Resident Observation. This amendment is a net increase of \$66,000 for the Resident Observation of the ARPA projects. The changes to the Resident Observation for the project are shown below:

#### **Bids/Purchases**

m. Approval to purchase Lifepack Cardiac Monitor/Defibrillator

The Crossville Fire Department requests approval to purchase a Physio Control Lifepack Model 35 Cardiac Monitor/Defibrillator package. The cardiac monitor defibrillator package will improve the Paramedics and AEMT's ability to treat patient's suffering from cardiac conditions. In addition, the unit will be capable of transmitting the patient's 15 lead EKG to the hospital medical staff prior to the patient's arrival allowing doctors to diagnose potential life ending heart attacks even before the patient arrives to the emergency room. This unit will be the same model used by Cumberland County EMS which will increase proficiency and treatment. The unit was not on the market at the time of budgeting and comes in a bit higher than anticipated. There is \$55,200 in Line item 42200-940-006, and the total cost with the procare annual service plan is \$64,373.57. A budget amendment is necessary.
