Buyer will deemed to have assented to these terms and conditions unless WASCON receives written notice of any objection within ten (10) days after Buyers receipt of this form. WASCON objects to any additional or different terms contained in any purchase order or other communication previously or hereafter provided to Buyer to WASCON. Additional, supplemental, or different terms or conditions will not be binding upon WASCON unless specifically agreed to in writing.

## **PRICES**

All previous prices are withdrawn. Prices quoted by WASCON are valid for 30 days, unless explicitly written otherwise within the offer or quote provided. All prices are quoted and payable in U.S. dollars. WASCON reserves the right to change prices with 30 days' notice.

#### APPROVAL OF ORDERS

All orders shall be subject to rejection or acceptance by WASCON.

#### **TAXES**

Any sales, use or other similar type, taxes imposed on this sale or transaction are not included in the pricing, unless explicitly written within the offer. Such taxes shall be billed separately to the Buyer. Seller will accept a valid exemption certificate from the Buyer if applicable; however, if an exemption certificate previously accepted is not recognized by the governmental taxing authority involved, and the seller is required to pay any tax not covered by an accepted exemption certificate, Buyer agrees to promptly reimburse seller for the tax paid.

# **SHIPPING DATES**

Ship dates are approximate and subject to change and are based upon prompt receipt of all necessary information. Seller shall not be responsible for nonperformance or delays in performance occasioned by any causes beyond the seller's reasonable control, including, but not limited to labor difficulties, delays of vendors or carries, fires, governmental actions and/or material shortages. Any such delays shall affect a corresponding extension of Seller's performance dates which are in any event, understood to be approximate. In no event shall the Buyer be entitled to damages including but not limited to incidental or consequential damages for late delivery performance. WASCON will not be liable for damages of any kind, liquidated or unliquidated, on account of failure to meet delivery date. All errors, clerical or otherwise, are subject to correction.

# WARRANTY

All products /services are warranted only to the extent of the warranties provided by the respective manufacturers of these products and products are intended for usage and installations as stated in the manufacture's written recommendations. Any prior written or implied warranties or service/installations are superseded by this statement. Unless explicitly provided in writing by the Seller, warranty times begin and are initiated in accordance with the manufacturer's standards/terms and/or at the time of delivery, regardless of when the product is placed into service. In addition, improper storage or handling of the

product by the buyer that compromises the condition of the product may void the warranty and holds the Seller harmless from any liability.

# PRODUCT INSPECTION and ACCEPTANCE

It is the responsibility of the Buyer to thoroughly inspect the product at the time of delivery for apparent deficiencies, defects and/or damages. The Buyer is required to notify the Seller within ten (10) days of such product issues. Failure by the Buyer to provide such notice will forfeit any liability held by the Seller.

# **TITLE TRANSFER**

Title will transfer from WASCON to Buyer at point of delivery, unless otherwise agreed and confirmed in writing by WASCON. Any loss of and/or damage to material after delivery shall be at the Buyer's risk.

## **SHORTAGES**

Buyer shall immediately inspect the equipment upon receipt. Claims for shortages or nonconformance shall be submitted to WASCON in writing within ten (10) days after Buyer's receipt of the equipment. Time is of the essence regarding such notice. WASCON shall not be obligated to honor late claims.

#### **DAMAGES**

The buyer shall be responsible for handling and care of the equipment from the date of delivery. The seller shall not be liable for any loss of damage from the time of delivery. Claims for damages in transit shall be submitted to the common carrier and are not Seller's responsibility.

#### **ITEM PERFORMANCE**

The performance and description of any item quoted or sold herewith are in accordance with descriptive literature, catalog or specification sheets, as provided by WASCON. Dimensions so provided do not necessarily represent every feature or detail. Weights shown in catalogs, price schedule, quotations, or acknowledgements or orders are approximate and in no sense are guaranteed. It is the responsibility of the Contractor/Installer to field confirm and verify all dimensions.

## RESTOCKING

Buyer may not return any material delivered by WASCON without obtaining WASCON's written consent; a RMA number must be tagged to every returned item. A restocking fee up to 25% will be collected upon return of materials.

#### **TERMS**

Instances that require downpayments or progress payments will be outlined within the subject quote/offer/order. The net balance shall be due and payable at WASCON office within 30 days of delivery, unless otherwise defined. Unpaid balances after 30 days from delivery will accrue a penalty in the amount of 1.5% per subsequent 30-day period. In addition, WASCON shall be entitled to interest on any such indebtedness from the date due at the highest rate plus reasonable attorney's fees should an attorney be employed to collect any such indebtedness after default. Material is subject to shipment in whole or in part at the option of WASCON and each such shipment is subject to immediate invoicing.

Buyer agrees to pay all collection costs incurred, not to exceed 50% of the balance due. The buyer also agrees to pay all attorney fees and court cost incurred by collecting the indebtedness.

WASCON reserves the right to delay their final inspection/startup and any warranty work until payment in full has been made and the account has been satisfied in full.

# **CODES, PERMITS AND LICENSES**

It shall be the Buyer's obligation, at its own cost and expense, to obtain all building or other permits, special fees and licenses required by any federal, state, local or other governmental authority with respect to approval of equipment in Buyer's location. The Seller does not represent or warrant that the equipment bought or sold here under meets all local codes and permits.

# **EFFECT OF TERMS AND CONDITIONS**

The terms and conditions herein contained shall apply to any order or direction received from Buyer and no provision in any such order or direction from Buyer in any way modifying or changing said terms and conditions shall be binding upon WASCON.
