**3. Appointments****a. Sports Authority of the City of Crossville**

*Tracey Barnes and Rob Pattons' terms will expire on February 13, 2026. They have both agreed to continue to serve on the Sports Authority for another term of 6 years.*

**5. Consent Agenda****Approval of the Consent Agenda**

*Mayor Pro-tem Art Gernt stated all the items on the Consent Agenda had been discussed the week prior at the monthly Work Session and were recommended by Staff. The public was invited to attend the Work Sessions.*

*Council member Mayberry requested to pull item K for further discussion.*

**Ordinances on Third Reading**

- a. Ordinance amending Title 8 Chapter 2 Beer
- Staff recommends amending the Beer ordinance in its entirety to clarify license types, fees, inspections, duties of the beer board, and circumstances not currently address in the ordinance.*
- This Ordinance was adopted on third reading.**

- b. Ordinance amending FY 25-26 Budget
- A budget amendment is necessary to amend FY 25-26 budget for paving at Meadow Park Lake, Outside Agencies: Industrial Development Board, Police Department HVAC, and Water Tank Site Improvements.*
- This Ordinance was adopted on third reading.**

### **Ordinances on First Reading**

- c. Ordinance amending FY 25-26 budget
- An ordinance amending FY 25-26 is recommended for approval. The budget amendment is for the Dunbar Road sewer study and fees for bonds.*
- This Ordinance was approved on the first reading.**
- d. Ordinance amending §2-202 Leisure Service Committee
- A change has been requested to the Leisure Service Committee ordinance. The addition of a representative for "Tournaments" has been requested.*
- This Ordinance was approved on the first reading.**

### **Additional Consent Items**

- e. Approval of Minutes (CC 1/13, SC 1/16, WS 2/3)
- The Minutes were approved as recommended.**
- f. Approval to secure Webb Avenue property
- Prior to the work session starting the week prior, the Police Chief and City Attorney discussed actions the Police Department could take to deter trespassers on City owned property. City Attorney Randy York requested to add an item to the agenda.*
- The City owns property on Webb Avenue. The Police Chief has reported a problem with trespassers camping on the property. City Attorney Randy York recommended action to allow the Police Department to barricade all the entrances, post "No Trespassing" signs, and prosecute trespassers.*
- This Resolution was approved as recommended.**
- g. Approval of resolution for Purple Heart City

*The Daughters of the American Revolution, Crab Orchard Chapter, have requested the City of Crossville adopt a resolution supporting their application for the City of Crossville to become a Purple Heart City.*

**This Resolution was approved as recommended.**

**h.** Approval to submit a Letter of Intent for Healthy Built Environment Grant

*Approval to submit a letter of intent to the Tennessee Department of Health to apply for the Healthy Built Environments Grant. This is a grant up to \$80,000 for the “design and construction of structures to increase access to safe opportunities for physical activity, increase access to healthy foods, or build community resilience.”*

**This Resolution was approved as recommended.**

**i.** Approval of an easement for a public hiking trail

*Staff recommends approval of an easement for a public hiking trail. The easement will be between the City of Crossville and Catholic Diocese of Knoxville. The easement shall include the right of ingress and egress to and from the trail, the right to install signage, markers, and other improvements reasonably and necessary for the safe and proper use of the trail, and such other rights as are reasonably necessary or convenient for the enjoyment and maintenance of the trail. This easement shall be 25 feet wide and shall not include any portion of the waters of Obed River and Town Branch.*

**This Resolution was approved as recommended.**

**j.** Approval of financial policy

*Finance Director Nathan Clouse recommends adopting the an updated version of the Internal Control Policy.*

**This Policy was approved as recommended.**

**k.** Approval of contract amendment #6 for Meadow Park Lake expansion

*Proposals have been received for the full delivery services for compensatory mitigation. In order to move forward with awarding the proposal for this work, a contract must be developed and negotiated with the proposer.*

*The next step for J.R. Wauford and Company is to develop a contract with the proposed selected proposer for full delivery services for compensatory mitigation. Their anticipated cost for this is \$10,000. We believe the City Attorney would also have a cost of \$10,000 for this work.*

*The Meadow Park Lake expansion contract amendment number 6 with J.R. Wauford and Company is attached, which includes the contract development, the completion of the Army Corp permit, and the TDEC Permit for the Meadow Park Lake Expansion Project in an amount not to exceed \$100,000.*

*Additional components of the amendment include:*

- \$30,000 for work already performed, but in excess of the budget amount established by Engineering Agreement No. 5*
- \$60,000 for preparing the initial draft Section 404 Department of the Army Permit*

*application adequate to allow the U. S. Army Corps of Engineers to public notice the proposed permit, completion of the alternatives analysis, and completion of the Section 404 Department of the Army Permit application and the Aquatic Resource Alteration Permit application / Section 401 Water Quality Certification request incorporating comments by appropriate federal and state agencies.*

*If the City plans on moving forward with the expansion of the Meadow Park Lake reservoir, City Staff recommends the approval of amendment 6.*

*There is money budgeted for this contract amendment.*

*Council member Mayberry asked for a break down of the fees that were to be voted on. Director of Engineering Tim Begley explained that \$100,000 is for Wauford and expenses related to the permitting and \$10,000 is budgeted for attorney costs. This is a contract amendment and the money is already budgeted.*

*Wauford will also perform a preliminary rate study within the proposed budgeted amount.*

*It was noted that this contract amendment does not obligate the City to future expenses.*

**A motion was made by Council Member James Mayberry, seconded by Mayor Pro-tem Art Gernt, to approve amendment number 6 contingent on any changes requested by the City Attorney and with the additional preliminary rate study. The motion carried by the following vote:**
