Description: Adjustment of Quantities based on work done. Reducing items 1 by 5,869 (\$23,476), item 2 by 2,056 (\$6,168), item 4 by 2 (\$6,000), item 5 by 1 (\$4,000), item 6 by 1 (\$4,000), item 7 by 50 (\$10,000), item 13 by 2 (\$7,000), item 14 by 1 (\$4,500), item 15 by 20 (\$1,500) item 16 by 1 (\$500), item 18 by 1 (\$750), item 23 by 100 (\$10,000), item 24 by 25 (\$500) and item 25 by 25 (\$3,750).
