ORDINANCE NO. _____

AN ORDINANCE TO ADJUST THE CORPORATE BOUNDARIES OF CROSSVILLE, TENNESSEE.

WHEREAS, it now appears that the prosperity of this city and of the territory herein described will be materially retarded and the safety and welfare of the future inhabitants and prosperity thereof endangered if such territory is not annexed; and

WHEREAS, the annexation of such territory is deemed necessary for the welfare of the future residents and property owners thereof and of this city as a whole;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROSSVILLE, TENNESSEE that:

SECTION I. The following described areas, lying the first Civil District of Cumberland County, Tennessee are hereby annexed into the corporate limits of Crossville, Tennessee:

Tax Map 125, Parcel 33.02 and ROW of Lantana (Eldridge – 12 Dunbar Road)

southeastern right-of-way of Lantana Road to a point, said point being a property corner of Tax Map 125M, Group A, Parcel 7.00 at the intersection of McKinley Lane and Lantana Road; thence in a northern direction crossing the right-of-way of McKinley Lane to a point, said point being a property corner of Tax Map 125L, Group A, Parcel 1.02; thence in a northern direction following the right-of-way of Lantana Road to a point, said point being the BEGINNING, containing approximately 4.52 acres.

SECTION II. Pursuant to <i>Tennessee Code Annotated</i> §6-51-102(b)(4), a Public Hearing on this annexation was held on, with legal notice of said Public Hearing advertised in the <i>Crossville Chronicle</i> on as well as all local radio stations.	
SECTION III. This annexation shall take pursuant to <i>Tennessee Code Annotated</i> §	effect from and after its final passage and 6-51-102, the public welfare requiring it.
