Cantrell Division II

The owners of the property formerly known as Mariner's Pointe Resort are submitting a new plat to replace the two previous plats submitted to the Crossville Regional Planning Commission. One of those plats has been approved and recorded as Plat Book 12 page 157. The second plat has been on hold by the Planning Staff for an issue involving water meters to be resolved. Once the matter was resolved, the owner requested the city to hold the plat for two weeks. They are now submitting this plat which will replace the plat that was being held. There are two main changes from the previous plats. One change is the location of the ingress/egress for Tract 1 and 2. It was previously across the paved area of the remainder, but is now being proposed

along an access road on the edge of the remainder, with a small portion crossing Tract 2 and Tract 1. The second change is the proposed size of Tract 2. The original proposed size of Tract 2 was 0.56 acres being cut off the remainder. The new proposed size is 1.05 acres. Since this revision still does not have access for Tract 1 or Tract 2 to a public ROW, a variance is being requested. Staff recommend approval of the plat as submitted along with the request for a variance, pending signatures on the appropriate documents.
