Call to Order

Secretary Rob Harrison called the meeting to order at 12:03 p.m.

Present 4 - Gordon Atchley, Council Member Rob Harrison, Greg Tabor, and Mayor James Mayberry

Absent 2 - Kevin Poore, and Chairman Mike Moser

Others present were City Manager Greg Wood, Don Cole, Kevin Dean, and Malena Fisher.

1. Approval of 11/15 minutes

Motion made by Gordon Atchley, seconded by Greg Tabor, to approve the November 15 minutes. Motion carried by the following vote:

2. Elections of Officers

Current chairman is Mike Moser, vice-chairman is Kevin Poore, and secretary is Rob Harrison.

3. Release of a Financial Guarantee, The Gardens Phase 8, Plat 1

The developer has completed the binder paving and curb for The Gardens Phase 8, Plat 1, Holly Tree Drive. Approximately 875 feet of new binder and curbing have been installed, inspected, and accepted by the City Street Department Supervisor. Staff recommends the approval for the release of the financial guarantee, a Letter of Credit

in the amount of \$90,899, and the recommendation to City Council the acceptance of this street as an Official City Street.

A motion was made by Kevin Poore, seconded by Greg Tabor, to approve the release for the financial guarantee and recommend to the City Council that the 875 feet of Holly Tree Drive be accepted as an official City Street. The motion carried by the following vote:

4. Release of a Financial Guarantee, Panther Valley Phase 2

The developer has completed paving for Panther Valley Phase 2, approximately 1480 feet. The new binder paving has been inspected and approved by the City's Street Department. Staff recommends approval of the release for the financial guarantee for Panther Valley Road, which is in the form of an escrow account in the amount of \$81,134 and recommendation to the City Council the acceptance of this street as an official City Street.

A motion was made by Mayor Mayberry, seconded by Greg Tabor, to approve the release of the financial guarantee and recommend to the City Council that Panther Valley Road be accepted as an official City Street. The motion carried by the following vote:
