To: Mayor J. H. Graham & Members of the City Council

Requested: The 30 MPH speed limit in Deer Creek is simply not safe.

It needs to be reduced to 25 MPH. Here are several of the reasons:

- 1) The community has now filled up and we 240+ homes utilizing only two main roads.
- 2) There are no side walks in Deer Creek, therefore walkers, joggers, bicyclists share the roadway.
- 3) The streets are narrow and many of the corners have blind areas so you can not see what is immediately around the corner. Therefore it is difficult to see Mail Vehicles and delivery trucks parked in the road.
- 4) Golf Carts also cross or drive down the roads as well as Golf Maintenance equipment.
- 5) We have had multiple occurrences of pedestrians having to jump off the road to avoid being hit or of cars sliding off the roads in inclement weather.
- 6) We need to reduce the speed in our community before there is a fatal accident.
