Public Comment

A motion was made by Mayor R.J. Crawford, seconded by Council Member James Mayberry, to suspend the rule during Public Comment allotting for only 15 minutes. The motion carried by the following vote:

Ron Webb is a local property owner who questioned the need for a duplicate service and the financial strain it would cause.

Janelle Cochran, a County resident, questioned if there is the deficiency of current EMS program, and if there is a deficiency, asked Council why they cannot work with

the County to resolve the problem? She stated Cumberland County EMS is highly rated and efficient. She encouraged Council to rescind their previous vote.

Tom Isham, a County Commissioner, presented a resolution signed by all 18 Commissioners opposing the City-run service. He stated citizens and businesses do not want higher taxes. He encouraged working together to fix any issues together.

Randy Davis, Covenant Health CEO/President, praised the strong partnership with the Cumberland County EMS and stated he was unaware of any problem that needed solving.

Craig Clark, a County resident, shared his testimony regarding Cumberland County EMS saving his life during a massive heart attack. He requested Council to rescind the vote and pursue collaboration with Cumberland County.

Roger Baker, a local business owner, doesn't want taxes raised for this service. He praised Cumberland County EMS for providing great service.

Bruce Wyatt, a City resident, expressed concern over the lack of cooperation between City and County officials, recalling past animosity that hurt the community. He urged elected officials to work together.

Jerry Brownstead, a City resident, is against a tax increase due to many citizens being on a fixed income. He commended Cumberland County EMS for doing an outstanding job.

Asa Reese, a Downtown business and property owner, warned that doubling property taxes could force businesses like his out of the area.

Cheri Carson, a City resident, argued the proposal does not represent the people, solve a problem, or make an improvement, and called on two Council members to recuse themselves from future votes due to personal interests.

Ordinances on Third Reading

Ordinance approving the abandonment Right-of-Way for a portion of Shepherd's Way, Central Baptist Church

Central Baptist Church is currently developing a master plan for their campus. A portion of that plan is to increase parking capacity. While they are just in the design and planning phase of the plan, they foresee needing to close a portion of the right of way of Shepherd's Way for use of parking and for the safety of their congregation in walking from their cars to the church. There have been some complaints about through traffic traveling Shepherd's Way at higher rates of speed. At this time, they are

seeking a guarantee from the City, that if they meet all the requirements that have been explained by Planning Staff (platting, construction of a cul-de-sac, and the survey work required by the City to abandon Right-of-way) that the City will then abandon the right-of-way for the church. They do not want to move forward in spending the required funds to meet all the requirements and then the City to deny the right-of-way closure. They anticipate the formal request to close the right-of-way within a year.

City Staff conducted a traffic count of Shepherd's Way at both ends, near the intersection of Dunbar Lane and the intersection of Highway 127 S. From the traffic count, it does appear that most traffic on the road is on Sundays and Wednesdays and most of the traffic does use the Highway 127 entrance over the Dunbar Lane side. Average Daily Traffic counts being:

Dunbar Lane Side: 389

· Highway 127 South Side: 1,007

Staff recommends that the Crossville City Council move forward with the passage of an Ordinance closing/abandoning the right-of-way between the edge of the proposed cul-de-sac and Highway 127 South, contingent upon all the requirements of plats, construction of the new cul-de-sac be completed within 3 years of the 3rd reading of the Ordinance, as well as a financial guarantee be provided to the City of Crossville for any damage to the existing portion of Shepherd's Way that may require maintenance or upkeep during the construction phase of the cul-de-sac. The amount of the financial guarantee to be determined by City Staff and agreed upon by the church before the passing of the Ordinance. The ordinance would be rescinded and the right-of-way would remain public should any requirements not be met.

This Ordinance was adopted on third reading.

Ordinance amending §18-304 Design Criteria

An ordinance amending §18-304 Design Criteria is recommended by staff to reference the International Plumbing Code for grease traps rather than an outdated appendix.

This Ordinance was adopted on third reading.

Ordinances on Second Reading

c. Ordinance amending Title 2, Chapter 2 Sports Council

The current Chapter establishes the Sports Council. By amending the ordinance, this establishes a Leisure Services Committee to combine multiple boards/committees working towards similar goals.

Ordinance amending §14-1104 - Review process, fees, and financial guarantees

An ordinance amending §14-1104 is recommended for approval. This amendment would allow for a financial guarantee to be required by Planning Commission at the time of site plan review.

An ordinance amending Title 14, Chapter 10 is recommended for approval. This adds the definition for "maintenance agreement" and adds a section regarding multi-family cluster housing development requirements for fire lines.
