AN ORDINANCE TO ADJUST THE CORPORATE BOUNDARIES OF CROSSVILLE, TENNESSEE.

WHEREAS, it now appears that the prosperity of this city and of the territory herein described will be materially retarded and the safety and welfare of the future inhabitants and prosperity thereof endangered if such territory is not annexed; and

WHEREAS, the annexation of such territory is deemed necessary for the welfare of the future residents and property owners thereof and of this city as a whole;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROSSVILLE, TENNESSEE that:

SECTION I. The following described areas, lying the first Civil District of Cumberland County, Tennessee are hereby annexed into the corporate limits of Crossville, Tennessee:

## Tax Map 127 Parcel 6.01 (S & J Properties-Lot 1)

BEGINNING on a point, said point being a common property corner of Tax Map 127 Parcel 7.01 and Tax Map 127 Parcel 6.01 located on the southwestern ROW of Hwy 127 South; thence in a southwestern direction following a common property line of Tax Map 127 Parcel 7.01 and Tax Map 127 Parcel 6.01 to a point, said point being a common property corner of Tax Map 127 Parcel 7.01 and Tax Map 127 Parcel 6.01; thence in a southeastern direction following a common property line of Tax Map 127 Parcel 7.01 and Tax Map 127 Parcel 6.01 for 96.89 feet to a point, said point being on a common property line of Tax Map 127 Parcel 7.01 and Tax Map 127 Parcel 6.01; thence in a north eastern direction following the bearing N 43°47'00" E. for 313.22 feet to a point; thence in a northwestern direction following the bearing N 42°52'42" W for 28.25 feet to a point; thence in a northeastern direction following the bearing N 47°03'33" E for 119.9 feet to a point, said point being on the southwestern ROW of Hwy 127 South; thence in a northeastern directions crossing the ROW of Hwy 127 South to a point, said point being a common property corner of Tax Map 127 parcel 5.00 and Tax Map 127 Parcel 11. 00; thence in a northwestern direction following the northeastern ROW of Hwy 127 South for approximately 81.3 feet to a point, said point being the existing City Limits of Crossville, TN; thence in a southwestern direction crossing the ROW of Hwy 127 South to a point, said point being the BEGINNING, containing approximately 1.12 acres.
