

RESOLUTION

WHEREAS, the City of Crossville has determined water and road improvements are needed for Iris Circle, Westheria Dr., and Narcissus St.;

A. The geographical limits of the properties to be benefited being a tract of land within the City limits of Crossville, Cumberland County, Tennessee, and being a portion of the Hideaway Hills Mobile Home Park Block T-1, recorded in Plat Book 4, Page 20 and Plat Book 4, Page 29; Register's Office, Cumberland County, Tennessee, consisting of the lots described as follows:

B. The improvements addressed hereby shall be located in the above-referenced subdivision and shall include a paved road and a low pressure sewer system with a preliminary estimate of cost estimated by T. C. Miller, P. E., of TARE, Inc., dated August 19, 2014 in the total amount of Two Hundred Thirty-Nine Thousand, Nine Hundred Dollars (\$239,900) (see attached Schedule "A"), with improvements to be designed and construction to be supervised by an engineer licensed by the State of Tennessee.

C. Seventy-five percent (75%) of the total cost herein shall be assessed against the benefited properties with said assessment not exceeding seventy-five percent (75%) of the total costs of the improvements with the City of Crossville providing twenty-five percent (25%) of the total costs of the above-described improvements pursuant to T.C.A. §7-33-303, et seq.

WHEREAS, the City of Crossville shall, pursuant to T.C.A. §7-33-303, provide proper notice of this Resolution and shall schedule a public hearing as follows:

A. This Resolution shall be published, along with a notice of the public hearing which is hereby scheduled for the 14th day of October, 2014, at 5:45 o'clock p.m. at the Crossville City Hall;

B. This Resolution and notice of hearing designated hereby shall be published at least seven (7) days in advance of the aforesaid hearing in a newspaper of general circulation with the City of Crossville and also by posting at the main office of the City of Crossville;


C. The notice herein shall stipulate that any owner of property to be benefited may appear to be heard as to:

1. Whether the proposed improvement shall be undertaken as planned, or abandoned;
2. Whether the nature and scope of the improvement should be altered; and
3. Whether the improvement should be financed through the issuance of bonds on the "assessed value basis" as authorized by T.C.A. §7-33-303, et seq.

D. The notice described herein shall also be sent by registered first-class mail, return receipt requested, to the owners of the properties to be benefited or their agents of record, at the time of the adoption of this Resolution, at the addresses currently entered on the property assessment records of the City of Crossville.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CROSSVILLE, TENNESSEE, that the above-referenced general plan of improvements be carried out in accordance with T.C.A. §7-33-303, et seq., the public welfare requiring same.
