

**Meadow Park Lake Management Hunting Rules** (Updated 05/18/09)      Receipt # \_\_\_\_\_

Hunters must have a current hunting/fishing license and follow rules and regulations set forth by Tennessee Wildlife Resources Agency. Hunters must purchase hunting permit from the Lake Manager to hunt MPL property. Hunting permits do not include lake access (fishing) or ramp access.

**Approved Weapons**

Shotgun class weapons only! **No handguns or rifles**

Bows may be used during bow season and by anglers who bow fish.

Hunters entering by boat must have the required permits. Permits must be displayed in vehicle window if parked within park property and a second copy with the hunter.

**Vehicles**

There are to be **no motorized vehicles** on MPL property. Walk in hunters entering property from City Lake Rd. must park on county right of way or in designated parking lot. Do not block gate or drive in fields. Hunters are restricted from entering or parking inside the fenced in area at the treatment facility. Hunters entering MPL property from private land must abide by the no vehicle on park land policy and weapon restrictions. Permit holder must have written permission stating property owner is aware that permit holder is using said property to access Meadow Park property.

It is the responsibility of the hunter to learn MPL property boundaries.

**There is to be no hunting within the following areas:**

The two cleared fields on each side of City Lake Rd. entering park property (These are safe zones and wildlife viewing areas.

Upper Campground / Boy Scout Camp

The wooded area and field opposite the Boy Scout Camp on lake side

Fenced in area surrounding the Water Treatment Facility

Marina, campground, and picnic area

Police Firing Range

Duck Hunting or any other type hunting is not allowed within the marina and pump house area. This is the area beginning at the marina all the way to the points on the left and right side.

There is to be no hunting from the lake side of the ridge across from Marina from the Dam to the point. Hunters may hunt the other side of that ridge away from the lake.

All other areas marked (on map) as restricted areas.

The undersigned has received orientation from Lake Manager, Marlene Potter on the above rules to hunt Meadow Park Lake. Permits may be revoked at any time for good reason.

2. That I will present the permit card to any authorized officer or Lake Personnel if called upon to do so.
3. That I will not remove more wildlife than the state authorized limit.
4. In the event of damages to park property I will pay for said damages.
5. To abide by the Meadow Park Lake Hunting Rules (see attached sheet)
6. That the City of Crossville may revoke this permit because of my failure or refusal to comply with any of the rules and regulations governing the Lake Property.
7. The undersigned hereby agrees to abide by all applicable laws, statues, rules and regulations with regard to their activities on and around Meadow Park Lake, including, without limitation, those promulgated by the Tennessee Wildlife Resources Agency and by the City of Crossville, and hereby agrees to do nothing illegal or unlawful.
8. The undersigned hereby agrees to indemnify and hold harmless the City of Crossville, it agents and employees, from and against all claims, if any, arising out of, or related to, the activities of the undersigned while on real property owned by the City of Crossville and while on or about Meadow Park Lake Property and this indemnification and hold harmless obligation by the undersigned shall include, without limitation, all claims for property damage, bodily injury and death and further, includes the obligation of the undersigned to pay all reasonable attorney fees, court costs and expenses, if any, incurred buy the City of Crossville with regard to all of said claims, to include both threatened claims and claims actually filed.
