

ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE TO ADJUST THE CORPORATE BOUNDARIES OF CROSSVILLE, TENNESSEE.

WHEREAS, it now appears that the prosperity of this city and of the territory herein described will be materially retarded and the safety and welfare of the future inhabitants and prosperity thereof endangered if such territory is not annexed; and

WHEREAS, the annexation of such territory is deemed necessary for the welfare of the future residents and property owners thereof and of this city as a whole;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROSSVILLE, TENNESSEE that:

SECTION I. The following described areas, lying the first Civil District of Cumberland County, Tennessee are hereby annexed into the corporate limits of Crossville, Tennessee:

**Lantana Rd Tax Map 126, Parcel 08.00 (portion) ~0.77 acres**

BEGINNING on a point, said point being a common property corner of Tax Map 126, Parcel 8.00 and Tax Map 126, Parcel 10.00 on the southeastern right-of-way of Lantana Road; thence in a southeastern direction following the common property line of Tax Map 126, Parcel 8.00 and Tax Map 126, Parcel 10.00 for 296.34 feet to a point, said point being on the common property line of Tax Map 126, Parcel 8.00 and Tax Map 126, Parcel 10.00; thence in a southwestern direction for 114.18 feet to a point, said point being inside Tax Map 126, Parcel 8.00; thence in a northwestern direction for 314.59 feet to a point, said point being on the southeastern right-of-way of Lantana Road; thence in a northeastern direction following the southeastern right-of-way of Lantana Rd to a point, said point being the BEGINNING.

SECTION II. Pursuant to *Tennessee Code Annotated* §6-51-102(b)(4), a Public Hearing on this annexation was held on \_\_\_\_\_, with legal notice of said Public Hearing advertised in the *Crossville Chronicle* on \_\_\_\_\_ as well as all local radio stations.
