

ORDINANCE NO. _____

AN ORDINANCE TO ADJUST THE CORPORATE BOUNDARIES OF CROSSVILLE, TENNESSEE.

WHEREAS, it now appears that the prosperity of this city and of the territory herein described will be materially retarded and the safety and welfare of the future inhabitants and prosperity thereof endangered if such territory is not annexed; and

WHEREAS, the annexation of such territory is deemed necessary for the welfare of the future residents and property owners thereof and of this city as a whole;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROSSVILLE, TENNESSEE that:

SECTION I. The following described areas, lying the first Civil District of Cumberland County, Tennessee are hereby annexed into the corporate limits of Crossville, Tennessee:

Myrtle Avenue (642 Myrtle Ave.)

BEGINNING on a point, said point being approximately 93 feet east of a common property corner of Tax Map 113, Parcel 11.00 and Tax Map 113, Parcel 11.09 on the northern right-of-way of Myrtle Ave; thence in a northwestern direction following the existing City Limits crossing Tax Map 113, Parcel 11.09 and Tax Map 113, Parcel 11.00 to a point, said point being on a common property line of Tax Map 113, Parcel 11.00 and Tax Map 113, Parcel 12.03; thence in a western direction following a common property line of Tax Map 113, Parcel 11.00 and Tax Map 113, Parcel 12.03 to a point, said point being a common property corner of Tax Map 113, Parcel 11.00 and Tax Map 113H, Group F, Parcel 9.00; thence in a southern direction following the western property line of Tax Map 113, Parcel 11.00 to a point, said point being a common property corner of Tax Map 113H, Group F, Parcel 1.00 and Tax Map 113, Parcel 11.00 and located on the northern right-of-way of Myrtle Ave.; thence in an eastern direction following the northern right of way of Myrtle Ave to a point, said point being the BEGINNING, approximately 6.85 acres.

SECTION II. Pursuant to *Tennessee Code Annotated* §6-51-102(b)(4), a Public Hearing on this annexation was held on _____, with legal notice of said Public Hearing advertised in the *Crossville Chronicle* on _____ as well as all local radio stations.

SECTION III. This annexation shall take effect from and after its final passage and pursuant to *Tennessee Code Annotated* §6-51-102, the public welfare requiring it.
