Terms of Agreement

- 1. The Tennessee Department of Agriculture (TDA) provides funds through the 319 Nonpoint Source Grant Program to the Grantee for cost-sharing with cooperators on a reimbursement basis to establish Best Management Practices (BMPs) for the control of nonpoint source pollution and improvement of water quality. For most BMPs, cost estimates will be at or less than the USDA-NRCS State Average Cost List applicable at the time of application for the location of the BMP. Similarly, BMPs will generally conform to the design standards of the NRCS Field Office Technical Guide and the Guidelines of the TDA Agricultural Resources Conservation Fund, where applicable.
- 2. The Maximum Cost Share Amount offered by the Grantee through this Agreement is indicated in Item 8 below and depends on the stream designation for the stream that will be improved. The Grantee will provide 60 75% of the actual cost of establishing the BMP, or up to 85% of the actual cost of BMPs in impaired watersheds, or the Maximum Cost Share Amount, whichever is less. The portion that is the cooperators responsibility may be met in cash or in-kind support for the BMP installation. Cost estimates are provided by the Grantee prior to acceptance of the project.
- 3. I agree to protect the integrity of the BMP by not changing the use of the riparian zone and flood plain, by not removing trees or other planted vegetation designed to stabilize the project area. I understand that this restriction does not prevent activities designed to protect the effectiveness of the BMP treatments, for example, removing fallen trees from the stream or from fences. If I sell the land, I agree that this same expectation of not disturbing the BMP will be made a condition of the sale or transfer by securing the agreement of the new owners to the terms of this Agreement. I agree that if I choose to remove native vegetation from the riparian zone of the project area or otherwise reduce the effectiveness of the BMPs, I shall reimburse TDA a prorated amount for any shortened life of any practice.
- 4. If I accept cost-share assistance from the Grantee, I agree that neither the Grantee nor I will be liable for any damage to the other's property or personal injury resulting from the implementation of the BMPs listed below.
- 5. I agree that the Commissioner of TDA or his designee; or if applicable, the NRCS State Conservationist or his designee; or the Grantee or their employees may periodically enter my property for the purpose of determining compliance with this Agreement.
- 6. Based on the above, I hereby request cost-share for the following BMP(s) listed below and all work described in more detail in the project description:
