A set of plans for an equipment upgrade and installation of new antenna for T-Mobile was submitted. The City's Telecommunication ordinance strongly recommends the use of cohabitation or tower sharing of multiple telecommunication companies in lieu of the erection of new towers. This upgrade/addition is just that, a shared tower.
