Crossville Shooting Sports Park, Inc.

Mayor Pro-Tem J. H. Graham presented a resolution rescinding the contract with Crossville Shootings Sports Parks, Inc. It was reported that there were 42 signatures on the petition, which appears to be a majority of the property owners. There are approximately 7 homes on Albert Frye Rd.

Those in opposition of the motion pointed out there have been 7 meetings in reference to the shooting sports park. They also reported that considerable time has been spent by staff, TWRA, U.S. Fish & Wildlife, and Historic Preservation and all the environmental surveys have been completed. It was also pointed out that it was a very sought after grant and the City Council had approved the agreement. The benefits of the sport for the youth was presented.

Those in favor of the motion commented that they want the facility, but in another location and that there should have been a public hearing. They also pointed out there are a lot of unknowns about the project and future development of property in the area.

A motion was made by Mayor Pro-tem J. H. Graham, seconded by Council Member Danny Wyatt, that the resolution rescinding the contract with Crossville Shooting Sports Park, Inc. for the purchase of real estate be approved. The motion carried by the following vote:
